Re: Sav-Rx COVID-19 Vaccination Program

Vaccinations for COVID-19 are here, and emergency use authorization (EUA) is imminent for several manufacturers. With a projected availability by the end of this year, the anticipated COVID-19 vaccine renews and strengthens the feeling of hope essential to the holiday season. In order to support our clients in making this benefit readily available to their participants, we have created the Sav-Rx COVID-19 Vaccination Program. This program will include automatic enrollment for all clients unless a signed version of the “Opt-Out Election Form” at the end of this letter is returned to Sav-Rx. Please note that we do not have control over who qualifies to receive the vaccine; this determination will be made by the individual states and then managed by the pharmacies that receive vaccine for administration.

Program Terms (For Non-Medicare Plans):

1. The program is only applicable to participants who are enrolled in the Plan’s Benefit.
2. The program only applies to COVID-19 vaccines that are authorized (EUA) or approved by the Food and Drug Administration (FDA).
3. The program will only last as long the federal government provides the COVID-19 vaccine at no cost, and you will only be responsible for administration fees. Once the federal government no longer covers the COVID-19 vaccine’s ingredient cost, your Plan will be notified and offered new COVID-19 vaccine coverage options.
4. The program will cover 100% of the cost of administration, with no cost share to the participant.
5. The Plan will pay the administration fee(s) for the number of doses recommended by the vaccine manufacturer. (At this point, all manufacturers anticipating FDA authorization or approval will require two doses of the COVID-19 vaccine.) The administration fees are listed below and apply to all pharmacies approved to administer the vaccine:

Single-Dose Administration Cost	Multiple-Dose Administration Cost
\$28.39	First Dose: \$16.94
	Second Dose: \$28.39

Program Terms (For Medicare Retirees):

1. Medicare Part B covers the cost and administration fee of COVID-19 vaccines that have been authorized or approved by the FDA.
2. If your plan has the UHC Medicare Advantage Program, it will cover the cost of the administration.
3. If your plan has an EGWP or PDP Plan through UHC, the administration fee will not be covered under this Part D benefit. You have the choice to either require retirees to utilize their Medicare Part B coverage or to have the Plan cover the vaccine through the Sav-Rx Wrap at the same administration costs and 100% cost share as outlined for Non-Medicare plans.
4. The program will last as long as the COVID-19 vaccine and its administration are covered under Medicare Part B. Once this changes, your Plan will be notified and be given new COVID-19 coverage options.
